

May 14, 2018

On this the 14th day of May 2018, the Coffee County Commission met in a regular meeting in the Multipurpose Room at Enterprise State Community College in Enterprise, AL at 9:00 AM. Those present at the said meeting were: Kim Ellis, Josh Carnley, Al Britt, Jimmy Jones, Jim Thompson and Tom Grimsley. Dean Smith, Commissioner and Chairman, was presiding with none absent. John R. Morgan, Administrator/Attorney, was also in attendance.

The Chairman noted that a quorum was present and the meeting was called to order. Matt Rodgers, ESCC President, welcomed everyone to the meeting.

Invocation was given by Commissioner Britt. The Pledge of Allegiance was led by Kinsley Morgan- ESCC Baptist Campus Ministries President and Caroline Morgan- ESCC SGA Senator.

Proclamation was presented by Chairman Smith and the Board of Registrars to Melissa Layton for being elected Favorite Principal at the first mock election held at the Enterprise City School's Spring Carnival.

Tammy Doerer, City of Enterprise Tourism Director, updated the Commission on the Main Street Alabama revitalization projects going on in downtown Enterprise. She also noted that the Boll Weevil will be turning 100 years old in 2019.

Ronnie Burns, Revenue Commissioner, presented the Annual Tax Settlement report to the Commission. Motion was made by Commissioner Ellis and seconded by Commissioner Grimsley that the Coffee County Commission accept the report as given. All voted Aye.

Motion was made by Commissioner Britt and seconded by Commissioner Jones that the Coffee County Commission adopt the minutes of the April 23, 2018 meeting. All voted Aye.

Bid#2018-10-Publication of Voters List was opened April 16, 2018 at 10:00 AM. The following bids were received: Enterprise Ledger-\$5,997.00

The Southeast Sun-\$7,805.00

Motion was made by Commissioner Jones and seconded by Commissioner Britt to award the bid to the Enterprise Ledger. All voted Aye.

Motion was made by Commissioner Smith and seconded by Commissioner Ellis that the Coffee County Commission authorize an agreement with Haynes Ambulance Service for medical services in the unincorporated areas of Coffee County. Commissioners Smith, Ellis, Britt, Jones and Grimsley voted affirmative. Commissioner Thompson voted negative and Commissioner Carnley abstained. Motion carried.

Motion was made by Commissioner Jones and seconded by Commissioner Carnley to reappoint Chairman Smith to serve as the ACCA representative for Coffee County. All voted Aye.

Motion was made by Commissioner Carnley and seconded by Commissioner Britt to extend Bid#2016-19 for a third 12 month term for fuel and gasoline with Petroleum Traders and Home Oil. All voted Aye.

Randy Tindell, County Engineer, requested a resolution authorizing the Commission to enter into an agreement with ALDOT to resurface CR114 from AL167 to Wayne Farms including turn lanes. Motion was made by Commissioner Ellis and seconded by Chairman Smith to authorize request. All voted Aye.

EMA Director, James Brown updated the Commission on the Reachout Campaign on address safety issues. He also noted that the Community Preparation Meeting will be held in the Community Room at 10:00 AM tomorrow.

Marvin McIlwain, E911, said that is it paramount that the City of Elba and the unincorporated areas of the County have a reliable ambulance service to provide for the citizens, since Elba doesn't have a hospital anymore.

Linda Blake, Board of Registrars, updated the Commission on important dates concerning the June 5th Primary Elections: May 21, 2018-last day to register to vote
May 31, 2018-last day to pick up absentee ballot

Sheriff Save Sutton updated the Commission about the Sheriff's Department making a drug bust in Elba. He also talked about the Law Enforcement Memorial that will be held on May 22, 2018 at 12 noon at the Elba Courthouse.

All the Commissioners thanked Enterprise State Community College for hosting the Commission Meeting as well as noting the importance of the College to our community.

With no further business, motion was made by Commissioner Carnley and seconded by Commissioner Britt that the Coffee County Commission adjourn until the next meeting on June 11, 2018. All voted Aye.
