

June 11, 2018

On this the 11th day of June 2018, the Coffee County Commission met in a regular meeting in the Commission Chambers in New Brockton, AL at 9:00 AM. Those present at the said meeting were: Kim Ellis, Al Britt, Jimmy Jones, Jim Thompson and Tom Grimsley. Dean Smith, Commissioner and Chairman, was presiding with one absent, Josh Carnley. John R. Morgan, Attorney/Administrator, was also in attendance.

The Chairman noted that a quorum was present and the meeting was called to order. Invocation was given by Commissioner Jones, followed by the Pledge of Allegiance.

Pastor Tim Beasock came before the Commission to request the rental fee for the Farm Center be waived for The Harvest youth ministry on Saturday, June 23, 2018. Motion was made by Commissioner Thompson and seconded by Commissioner Ellis to waive the rental fee. All voted Aye.

A Public Hearing was held concerning Landfill Expansion. There were two representatives from CDG Engineering in attendance to answer questions. Nancy Ann Westbrook and Ronnie Glen Westbrook were the only participants. No one spoke against the proposed expansion. Mike Thornton, Environmental Services, asked the Commission to issue a resolution supporting the permits required for a C&D cell on the existing property as well as the space available within the 77 acres purchased. Motion was made by Commissioner Ellis and seconded by Chairman Smith to do a resolution supporting permits for both C&D cells. All voted Aye.

Motion was made by Commissioner Ellis and seconded by Commissioner Grimsley that the Coffee County Commission adopt the minutes of the May 14, 2018 meeting. All voted Aye.

Motion was made by Commissioner Grimsley and seconded by Commissioner Jones to authorize the Sheriff's Office to sell two vehicles and use the money to purchase a 2018 Chevrolet Silverado. All voted Aye.

Motion was made by Commissioner Britt and seconded by Commissioner Ellis to update the County's Title VI policy. All voted Aye.

Motion was made by Commissioner Ellis and seconded by Commissioner Thompson to approve a contract with Marty Lentz to succeed Randy Tindell as County Engineer. Randy will be retiring the end of September. All voted Aye.

Motion was made by Commissioner Ellis and seconded by Commissioner Thompson that the Coffee County Commission approve two subdivisions because developers met all the required regulations:

Keyton Crossing-Minor Subdivision on CR712

The Ridge at Stephens Farms Phase III-Major Subdivision on CR700

All voted Aye.

James Brown, EMA Director, updated the Commission on upcoming events concerning hurricane preparedness. Hurricane season is June 1st through November 30th.

Dean Blair, Environmental Services, noted that Megan had her baby on Wednesday, June 6th and that he also had a grandson born on Monday, June 4th.
