

September 24, 2018

On this the 24<sup>th</sup> day of September 2018, the Coffee County Commission met in a regular meeting in the Commission Chambers in New Brockton, AL at 9:00 AM. Those present at the said meeting were: Josh Carnley, Al Britt, Jimmy Jones, Jim Thompson and Tom Grimsley. Dean Smith, Commissioner and Chairman, was presiding with one absent, Kim Ellis. John R. Morgan III, Attorney/Administrator, was also in attendance.

The Chairman noted that a quorum was present and the meeting was called to order. Invocation was given by Chairman Smith followed by the Pledge of Allegiance.

Chairman Smith presented a Meritorious Service Award to Sergeant Jace Holley for service above and beyond the call of duty when he responded to a wreck and pulled three children out of a burning vehicle on June 18, 2018.

Chairman Smith read a proclamation declaring September as Hunger Action Month.

Leda Green, Coffee County Community Church Mobile Food Pantry, updated the Commission on the date and time of the mobile food pantry. She stated fresh produce and food would be available on October 30, 2018 from 6:00 AM till 12 noon at the concrete floor arena in the Coffee County Complex. Sign up dates are October 4-5.

Motion was made by Commissioner Grimsley and seconded by Commissioner Jones that the Coffee County Commission adopt the minutes of the September 10, 2018 meeting. All voted Aye.

Motion was made by Commissioner Britt and seconded by Commissioner Thompson that the Coffee County Commission grant permission to Environmental Services to send out bids for the repair of a D6 Dozier. All voted Aye.

Motion was made by Commissioner Carnley and seconded by Commissioner Jones to renew the contracts with SARCOA allowing the Commission to continue to operate the six Senior Centers located in the county. All voted Aye.

County Engineer Marty Lentz read the results of the bid opening held on September 17, 2018 at 9:00 AM:

Motion was made by Commissioner Grimsley and seconded by Commissioner Britt that the Coffee County Commission award Bid#2019-02 to Wiregrass Construction. All voted Aye.

EMA Director James Brown updated the Commission on the Integrated Public Alert & Warning System (IPAWS) that will be conducting a nationwide test in the county on October 3, 2018 at 1:18 PM. The test alert will reach all cell phones made after 2016.

County Agent Gavin Mauldin gave an update on upcoming events at the Extension Office.

Sheriff Sutton thanked the Commission for recognizing Sergeant Jace Holley.

Commissioners thanked Sergeant Holley for his service to the county. They also thanked Mrs. Green for her dedicated work with the mobile food pantry.

With no further business, motion was made Commissioner Carnley and seconded by Commissioner Britt that the Coffee County Commission adjourn until the next meeting on October 8, 2018. All voted Aye.
