

July 22, 2019

On this the 22<sup>nd</sup> day of July 2019, the Coffee County Commission met in a regular meeting in the Commission Chambers in New Brockton, AL at 9:00 AM. Those present at the said meeting were: Kim Ellis, Josh Carnley, Al Britt, Jimmy Jones, Jim Thompson and Tom Grimsley. Dean Smith, Commissioner and Chairman, was presiding with none absent. John R. Morgan III, Administrator/Attorney, was also in attendance.

The Chairman noted a quorum was present and called the meeting to order. Invocation was given by Commissioner Britt followed by the Pledge of Allegiance.

Cheryl Leatherwood, Community Corrections, updated the Commission on the treatment program for inmates and requested a letter of support for the program. Motion was made Commissioner Thompson and seconded by Commissioner Jones that the Coffee County Commission honor the request. All voted Aye.

Motion was made by Commissioner Grimsley and seconded by Commissioner Britt that the Coffee County Commission adopt the minutes of the July 8, 2019 meeting. All voted Aye.

County Administrator Rod Morgan requested a resolution conditionally approving the Mapping and Appraisal budget that Ronnie Burns, Revenue Commissioner, submitted to the State. Motion was made by Commissioner Ellis and seconded by Commissioner Britt that the Coffee County Commission conditionally approve the Mapping and Appraisal budget. All voted Aye.

Motion was made by Commissioner Ellis and seconded by Commissioner Carnley that the Coffee County Commission release any claim to the Cool Springs Voting House building while maintaining any right of way interest the County has in the property as requested by County Administrator Rod Morgan. All voted Aye.
