

January 13, 2020

On this the 13<sup>th</sup> day of January 2020, the Coffee County Commission met in a regular meeting in Commission Chambers in New Brockton, AL at 9:00 AM. Those present at the said meeting were: Kim Ellis, Josh Carnley, Al Britt, Jimmy Jones, Jim Thompson and Tom Grimsley. Dean Smith, Commissioner and Chairman, was presiding with none absent. John R. Morgan III, Administrator/Attorney, was also present.

Chairman Smith noted that a quorum was present and called the meeting to order. Invocation was given by Commissioner Carnley followed by the Pledge of Allegiance.

Bryan Peacock, Assistant Principal NBHS, came before the Commission to request a waiver of the Farm Center rental fee for their sports banquet on January 26, 2020. Motion was made by Commissioner Thompson and seconded by Commissioner Carnley that the Coffee County Commission waive the rental fee. All voted Aye.

Motion was made by Commissioner Grimsley and seconded by Commissioner Ellis that the Coffee County Commission adopt the minutes from the December 23, 2019 meeting. All voted Aye.

Administrator Rod Morgan read the results of the bid opening held on January 7, 2019 at 11:00 AM:

Motion was made by Commissioner Britt and seconded by Commissioner Jones that the Coffee County Commission award Bid#2020-11 to The Enterprise Ledger. All voted Aye.

County Engineer Marty Lentz told the Commission that they have completed the first Rebuild Alabama Project in Heritage Heights and will start the other resurfacing projects on CR200 and CR723. He also said eleven county roads had trees/limbs in the roadway after the storm.

EMA Director James Brown updated the Commission on storm related issues in the county.

County Agent Gavin Mauldin updated the Commission on upcoming programs and events.

Motion was made by Commissioner Ellis and seconded by Commissioner Britt that the Coffee County Commission provide \$3,300.00 for the renovation of Jim Folsom's birthplace in Elba, which is 1/3 of the cost of the project. Commissioners Smith, Ellis, Carnley, Britt and Jones voted affirmative. Commissioners Thompson and Grimsley voted against the motion. This motion passed 5-2.

With no further business, motion was made by Commissioner Grimsley and seconded by Commissioner Britt that the Coffee County Commission adjourn until its next meeting on January 27, 2020.
