

February 10, 2020

On this the 10<sup>th</sup> day of February 2020, the Coffee County Commission met in a regular meeting in the Commission Chambers in New Brockton, AL at 9:00 AM. Those present at the said meeting were: Kim Ellis, Al Britt, Jimmy Jones, Jim Thompson and Tom Grimsley. Dean Smith, Commissioner and Chairman, was presiding with none absent. John R. Morgan III, Administrator/Attorney, was also in attendance.

Chairman Smith noted that a quorum was present and called the meeting to order. Invocation was given by Commissioner Britt followed by the Pledge of Allegiance.

Chairman Smith read a Proclamation declaring February 2020 as Career and Technical Education Month and a copy of the Proclamation was presented to each school system in Coffee County.

BJ Cardwell updated the Commission on the success of the Wiregrass Area Mobile Food Bank in our county and thanked the Commission for the use of County facilities for the Food Bank.

Motion was made by Commissioner Grimsley and seconded by Commissioner Jones that the Coffee County Commission adopt the minutes from the January 27, 2020 meeting. All voted Aye.

Motion was made by Commissioner Ellis and seconded by Commissioner Britt that the Coffee County Commission approve a resolution to surplus and transfer the title to a 2013 Chevrolet Tahoe from the Sheriff's Office to the City of Elba. All voted Aye.

County Administrator Rod Morgan came before the Commission to request permission for the Sheriff's Office to purchase three additional Chevrolet Tahoes off the State Bid List this fiscal year. He noted that this will be the last year the current model is offered. The Sheriff's Office has been budgeted four vehicles in previous years, but will only request one vehicle the next year if this request is approved. Motion was made by Commissioner Ellis and seconded by Commissioner Jones that the Coffee County Commission approve the purchase of three additional Chevrolet Tahoes from the State Bid List. All voted Aye.

Motion was made by Commissioner Carnley and seconded by Commissioner Smith that the Coffee County Commission change the polling location from the Elba Rec Department to the Elba Church of Christ located at 715 Troy Highway. All voted Aye.

County Engineer Marty Lentz came before the Commission to request permission to sell six Kenworth Dump Trucks at the J.M. Wood Auction for a guaranteed price of \$150,500 per truck. Motion was made by Commissioner Britt and seconded by Commissioner Ellis that the Coffee County Commission grant permission to sell the six dump trucks. All voted Aye.

Motion was made by Commissioner Carnley and seconded by Commissioner Britt that the Coffee County Commission allow County Engineer Marty Lentz to sell a 1994 Wheel Loader on GovDeals.com. All voted Aye.

County Engineer Marty Lentz noted that the resurfacing of CR200, which is the second Rebuild Alabama project, has started.

Mike Thornton, Environmental Services, requested permission to surplus and sell two 2007 Sterling Roll Off Trucks, one 2014 Polaris Ranger, one 2010 Dodge Ram Truck and one 2008 Compactor on GovDeals.com. Motion was made by Commissioner Grimsley and seconded by Commissioner Jones that the Coffee County Commission honor the request. All voted Aye.

Grant Lyons, EMA Deputy Director, noted that a Civilian Response to Active Shooter Events (CRASE) class will be offered on February 18, 2020 at ESCC at 6:00 PM. Twenty-four slots have been filled for the upcoming ICS 300 and 400 Training on February 24<sup>th</sup>-28<sup>th</sup>.

County Agent Gavin Mauldin updated the Commission on upcoming events:
