On this the 27th day of April 2020, the Coffee County Commission met in a regular meeting in Commission Chambers in New Brockton, AL at 9:00 AM. Those present at the said meeting were: Kim Ellis, Josh Carnley, Al Britt, Jim Thompson and Tom Grimsley. Dean Smith, Commissioner and Chairman, was presiding. Jimmy Jones was absent. John R. Morgan III, Administrator/Attorney, was also in attendance.

Chairman Smith noted that a quorum was present and called the meeting to order. Invocation was given by Commissioner Thompson followed by the Pledge of Allegiance.

Motion was made by Commissioner Grimsley and seconded by Commissioner Ellis that the Coffee County Commission adopt the minutes from the March 23, 2020 meeting. All voted Aye.

County Engineer Marty Lentz read the results of the bid opening held on March 31, 2020 at 9:00 AM:

Motion was made by Commissioner Carnley and seconded by Commissioner Ellis that the Coffee County Commission award Bid#2020-13 to W.S. Newell. All voted Aye.

County Engineer Marty Lentz read the results of the bid opening held on April 7, 2020 at 10:00 AM:

Motion was made by Commissioner Britt and seconded by Commissioner Carnley that the Coffee County Commission award Bid#2020-14 to Twin Oaks Environmental. All voted Aye.

Motion was made by Commissioner Thompson and seconded by Commissioner Britt that the Coffee County Commission grant permission to send out bids for a lime rock material as requested by County Engineer Marty Lentz. All voted Aye.

County Engineer Marty Lentz also requested permission to surplus and sell a 5-ton propane HVAC unit from the Elba Courthouse on GovDeals.com. Motion was made by Commissioner Grimsley and seconded by Commissioner Britt that the Coffee County Commission honor the request. All voted Aye.

Motion was made by Commissioner Carnley and seconded by Commissioner Ellis that the Coffee County Commission award the Coffee County Solid Waste Alternative Daily Cover Mulch (ADCM) bid to LSC Environmental. All voted Aye.

Motion was made by Commissioner Ellis and seconded by Commissioner Britt that the Coffee County Commission authorize or ratify the emergency declaration issued by County Administrator Rod Morgan on March 26, 2020, and all actions taken pursuant to such declaration. All voted Aye.

Motion was made by Commissioner Thompson and seconded by Commissioner Grimsley that the Coffee County Commission reappoint Jonathan Tullos to serve on the Southeast Alabama Regional Planning Commission Loan Administration Board. All voted Aye.

James Brown, EMA Director, updated the Commission on COVID-19.

County Administrator Rod Morgan urged citizens to respond to the 2020 Census.

With no further business, motion was made by Commissioner Grimsley and seconded by Commissioner Carnley that the Coffee County Commission adjourn until the next meeting on May 11, 2020. All voted Aye.
