

June 14, 2021

On this the 14<sup>th</sup> day of June 2021, the Coffee County Commission met in a regular meeting in Commission Chambers in New Brockton, AL at 9:00 AM. Those present at the said meeting were: Kim Ellis, Al Britt, Jimmy Jones, Jim Thompson and Tom Grimsley. Dean Smith, Commissioner and Chairman, was presiding. Josh Carnley was absent. John R. Morgan III, Administrator/Attorney, was also in attendance.

Chairman Smith noted that a quorum was present and called the meeting to order. Invocation was given by Commissioner Thompson followed by the Pledge of Allegiance.

Chairman Smith read a resolution honoring the 2021 Miss Coffee County Pageant Queens and presented each queen with a Coffee County pin. Pageant Director Ashley Merritt also spoke about the pageant history. The 2021 Miss Coffee County Pageant winners are:

County Administrator Rod Morgan came before the Commission to request permission to surplus and sell two patrol vehicles. Motion was made by Commissioner Jones and seconded by Commissioner Britt that the Coffee County Commission honor the request. All voted Aye.

County Engineer Marty Lentz came before the Commission to request the approval of a proposed minor subdivision plat that is in compliance with the County's rules and regulations. The Landing at Goodman Farms contains 14-lots and is located on County Road 625. Motion was made by Commissioner Jones and seconded by Commissioner Britt that the Coffee County Commission approve the subdivision. All voted Aye.

Motion was made by Commissioner Grimsley and seconded by Commissioner Ellis that the Coffee County Commission allow the conversion of two garbage trucks into roll off trucks using a Sourcewell bid for \$56,633.12 each. All voted Aye.

EMA Director James Brown stated the county had 12 cases of COVID in the last 14 days and his office would be returning to a normal disasters training schedule.

County Agent Gavin Mauldin updated the Commission on the Extension's upcoming events.

All of the commissioners congratulated the new Coffee County Queens.

With no further business, motion was made by Commissioner Grimsley and seconded by Commissioner Thompson that the Coffee County Commission adjourn until the next meeting on June 28, 2021. All voted Aye.
