

December 13, 2021

On this the 13th day of December 2021, the Coffee County Commission met in a regular meeting in Commission Chambers in New Brockton, AL at 9:00 AM. Those present at the said meeting were: Kim Ellis, Josh Carnley, Al Britt, Jimmy Jones, Jim Thompson and Tom Grimsley. Dean Smith, Commissioner and Chairman, was presiding the meeting. John R. Morgan III, Administrator/Attorney, was also in attendance.

Chairman Smith noted that a quorum was present and called the meeting to order. Invocation was given by Commissioner Jones followed by the Pledge of Allegiance.

A public hearing was held concerning the vacation of a portion of County Road 411. No one was in attendance and the public hearing was adjourned.

Motion was made by Commissioner Grimsley and seconded by Commissioner Carnley that the Coffee County Commission adopt the minutes from the November 22, 2021 meeting. All voted Aye.

Motion was made by Commissioner Jones and seconded by Commissioner Britt that the Coffee County Commission enter into a contract with Glenwood Forest Products to cut the timber at the landfill. All voted Aye.

Administrator Rod Morgan stated county offices will be closed on Friday, December 24th for Christmas Eve, Monday, December 27th for Christmas Day and Friday, December 31st for New Year's Day.

Motion was made by Commissioner Carnley and seconded by Commissioner Ellis that the Coffee County Commission vacate a **760 feet portion of County Road 411 located in the E ½ of the NE ¼ of Section 36, T-5-N, R-19-E.** All voted Aye.

Motion was made by Commissioner Ellis and seconded by Commissioner Britt that the Coffee County Commission grant permission to advertise a petition to vacate a portion of County Road 173 as requested by County Engineer Marty Lentz. All voted Aye.
