

January 9, 2023

On this the 9th day of January 2023, the Coffee County Commission met in a regular meeting in Commission Chambers in New Brockton, AL at 9:00 AM. Those present at the said meeting were: Kim Ellis, Sonny Moore, Jimmy Jones, Jim Thompson and Tom Grimsley. Dean Smith, Commissioner/Chairman, was presiding. Al Britt was absent. John R. Morgan III, Administrator/Attorney, was also in attendance.

Chairman Smith noted that a quorum was present and called the meeting to order. Invocation was given by Commissioner Jones followed by the Pledge of Allegiance.

Chairman Smith presented a resolution honoring Sheriff Dave Sutton for serving as Coffee County Sheriff for the last 16 years. Sheriff Sutton was also presented with his badge and his sidearm.

Motion was made by Commissioner Grimsley and seconded by Commissioner Jones that the Coffee County Commission adopt the minutes from the December 12, 2022 meeting. All voted Aye.

Motion was made by Commissioner Ellis and seconded by Commissioner Smith that the Coffee County Commission approve the FY2022 County Rebuild Alabama Annual Report as presented by County Engineer Marty Lentz. All voted Aye.

Motion was made by Commissioner Thompson and seconded by Commissioner Jones that the Coffee County Commission approve the purchase of a dump trailer for the Maintenance Department. All voted Aye.

Motion was made by Commissioner Moore and seconded by Commissioner Thompson that the Coffee County Commission authorize entering into a project funding agreement with the ALDOT to resurface and stripe CR 636 from AL 87 to AL 27. All voted Aye.
