

January 23, 2023

On this the 23rd day of January 2023, the Coffee County Commission met in Commission Chambers in New Brockton, AL at 9:00 AM. Those present at the said meeting were: Kim Ellis, Sonny Moore, Jimmy Jones, Jim Thompson and Tom Grimsley. Dean Smith, Commissioner/Chairman, was presiding. Al Britt was absent. John R. Morgan III, Administrator/Attorney, was also in attendance.

Chairman Smith noted that a quorum was present and called the meeting to order. Invocation was given by Commissioner Jones followed by the Pledge of Allegiance.

Motion was made by Commissioner Ellis and seconded by Commissioner Moore that the Coffee County Commission adopt the minutes from January 9, 2023 meeting. All voted Aye.

Motion was made by Commissioner Jones and seconded by Commissioner Ellis that the Coffee County Commission allow County Engineer Marty Lentz to surplus and sell a 2012 Ford F350 truck chassis on GovDeals.com. All voted Aye.

Motion was made by Commissioner Moore and seconded by Commissioner Thompson that the Coffee County Commission grant permission to sell two John Deere tractors with boom cutters at the JM Wood Auction in March as requested by County Engineer Marty Lentz. All voted Aye.

Motion was made by Commissioner Ellis and seconded by Commissioner Thompson that the Coffee County Commission allow the purchase of six 40-yard roll containers for \$50,152.36 for the Landfill. All voted Aye.

Motion was made by Commissioner Grimsley and seconded by Commissioner Smith that the Coffee County Commission award Bid#2023-16 CAT D6T Dozer Undercarriage Parts to the only respondent, Thompson Tractor, in the amount of \$22,968.88. All voted Aye.

Motion was made by Commissioner Jones and seconded by Commissioner Ellis that the Coffee County Commission allow the surplus and sell of sixty-three roll off containers and two 2005 roll off trucks on GovDeals.com. All voted Aye.

EMA Director James Brown updated the Commission on the weather last week.

Commissioner Jones attended a hospital board meeting on January 19, 2023. He stated that 37% of tested individuals tested positive for COVID in Coffee County.

With no further business, motion was made by Commissioner Grimsley and seconded by Commissioner Thompson that the Coffee County Commission adjourn until the next meeting on February 13, 2023. All voted Aye.
