On this the 12th day of June 2023, the Coffee County Commission met in Commission Chambers in New Brockton, AL at 9:00 AM. Those present at the said meeting were: Kim Ellis, Sonny Moore, Jimmy Jones and Jim Thompson. Dean Smith, Commissioner/Chairman, was presiding. Al Britt and Tom Grimsley were absent. John R. Morgan III, Administrator/Attorney, was also in attendance.

Chairman Smith noted that a quorum was present and called the meeting to order. Invocation was given by Commissioner Moore followed by the Pledge of Allegiance.

Motion was made by Commissioner Ellis and seconded by Commissioner Moore that the Coffee County Commission adopt the minutes from the May 22, 2023 meeting. All voted Aye.

Motion was made by Commissioner Ellis and seconded by Commissioner Smith to surplus and sell a senior center vehicle. All voted Aye.

Motion was made by Commissioner Thompson and seconded by Commissioner Ellis that the Coffee County Commission authorize and approve a memorandum of understanding with the Administrative Office of Court to provide funding for an additional court employee. All voted Aye.

Motion was made by Commissioner Thompson and seconded by Commissioner Moore that the Coffee County Commission authorize an agreement with VertiQ Software, LLC to provide software for the Coroner's Office. All voted Aye.

Motion was made by Commissioner Jones and seconded by Commissioner Thompson that the Coffee County Commission execute an agreement with The Asher Group for a new mass notification system. All voted Aye.

Motion was made by Commissioner Thompson and seconded by Commissioner Jones that the Coffee County Commission enter into an interagency cooperative agreement with ADEM for the remediation of solid waste along the right of way within Coffee County. All voted Aye.

Motion was made by Commissioner Jones and seconded by Commissioner Ellis that the Coffee County Commission adopt the new driveway policy as presented by County Engineer Marty Lentz. All voted Aye.

EMA Director James Brown thanked the Commission for the mass notification software. He also stated the county would be receiving 4-6 inches of rain this week.

Dean Blair, 911, updated the Commission on the new equipment being installed in his office for the new dispatch center.

County Agent Gavin Mauldin updated the Commission on upcoming events.

Commissioners thanked the Coffee County Queens for attending the meeting.

With no further business, motion was made by Commissioner Moore and seconded by Commissioner Thompson that the Coffee County Commission adjourn until the next meeting on June 26, 2023. All voted Aye.
